CHAPTER I

NAME, PLACE, AND TIME

Article 1

This meeting is named the General Assembly Meeting of the General Student Deliberation of the Faculty of Veterinary Medicine, Universitas Brawijaya, hereinafter abbreviated as General Assembly GSD FVM UB.

Article 2

The General Assembly GSD FVM UB is organised within the FVM UB environment.

Article 3

The General Assembly GSD FVM UB is held at the end of the management period.

CHAPTER II

OBJECTIVES AND AUTHORITIES

Article 4

Objective

The objectives of the General Assembly GSD FVM UB are:

1. To amend the main body of the Statutes and Bylaws, hereinafter referred to as the Statutes and Bylaws of the Student Collegium of FVM UB.
2. To establish the Statutes and Bylaws of the Student Collegium of FVM UB.
3. To discuss and establish the General Work Guidelines (GWG) of the Student Collegium of FVM UB.
4. To inaugurate the President and Vice President of the Student Executive Board (SEB), Members of the Student Representative Council (SRC), Congress Delegates, and

Heads of Semi-Autonomous Bodies (SAB) of FVM UB.

5. To decide and establish other matters deemed necessary.

The authorities of the General Assembly GSD FVM UB are:

1. To establish the Statutes and Bylaws of the Student Collegium of FVM UB.
2. To establish the GWG of the Student Collegium of FVM UB.
3. To inaugurate the President and Vice President of the Student Executive Board, Members of the Student Representative Council, Congress Delegates, and Heads of Semi-Autonomous Bodies of FVM UB.
4. To discuss and establish additional agendas.
5. to decide and establish other matters deemed necessary..

CHAPTER III

PARTICIPANT OF THE GENERAL ASSEMBLY GSD UB

Article 5

Participant Criteria

1. Participants consist of full participants and observers.
2. Full participants are all FVM UB students present at the General Assembly GSD FVM UB.
3. Observers are invitees who have been designated in advance by the Organising Committee (outside of FVM UB students) and approved by the full participants.

Article 6

Participant Rights

1. Full participants have the right to speak and the right to vote.
 - a. The right to speak includes the right to propose or reject proposals as well as the right to ask and answer questions.
 - b. The right to vote includes the right to elect and be elected, as well as to provide support during voting.
2. Observers only have the right to speak.
3. Any participant who wishes to propose a motion or speak in the General Assembly GSD FVM UB will be granted the right to speak after making an interruption request

4. When someone has been granted the right to speak to the assembly, no one may interrupt them except with the permission of the praesidium.

Article 7

Participant Obligations

Participants are obliged to:

1. Adhere to the Rules of Procedure for the General Assembly GSD FVM UB.
2. Full participants must attend the entire series of the General Assembly GSD FVM UB unless permitted by the praesidium.
3. Participants may enter and leave the meeting venue only with permission from the praesidium.
4. Wear appropriate and regulated attire as per the rules at FVM UB.
5. Maintain order throughout the General Assembly GSD FVM UB.

CHAPTER IV

PRAESIDIUM OF THE GENERAL ASSEMBLY GSD FVM UB

Article 8

The General Assembly GSD FVM UB is chaired by the Praesidium.

Article 9

The Praesidium is a unit consisting of Praesidium 1, Praesidium 2, and Praesidium 3.

Article 10

The Praesidium is nominated and elected by the participants of the General Assembly GSD FVM UB in a free and direct manner.

Article 11

Before the Permanent Praesidium of the General Assembly GSD FVM UB is elected, all sessions are led by officials appointed by the Organising Committee of the General Assembly GSD FVM UB, acting as the Temporary Praesidium.

Article 12

The election of the Praesidium of the General Assembly GSD FVM UB is carried out through:

1. A candidate for the Praesidium of the General Assembly GSD FVM UB is considered valid if nominated by at least 3 votes.
2. Each valid candidate must verbally express their willingness in front of the assembly
3. If there are only 3 willing candidates for the Praesidium, then those three candidates can be directly declared as the Praesidium.
4. If there are fewer than 3 willing candidates, a re-nomination can be conducted to add more candidates..
5. If there are more than 3 willing candidates, a deliberation among the candidates can be held for 2x1 minutes to select the valid Praesidium.
6. If the deliberation in the previous step does not reach a decision, voting will be conducted by the assembly to select the valid Praesidium.
7. The Chairperson of the General Assembly GSD FVM UB is determined or elected by the Praesidium of the General Assembly MGD FVM UB.

Article 13

Duties and Authorities of the Praesidium of the General Assembly GSD FVM UB:

1. Lead the meeting in accordance with the Rules of Procedure for the General Assembly GSD FVM UB.
2. Summarise the discussions in the General Assembly GSD FVM UB.
3. Organise and direct the General Assembly GSD FVM UB.
4. Issue warnings and sanctions to participants who violate the Rules of Procedure for the General Assembly GSD FVM UB.
5. Establish and ratify all the results of the General Assembly GSD FVM UB.

Article 14

1. Mechanism for Replacing the Praesidium of the General Assembly GSD FVM UB:
2. If Praesidium 1, who is leading the meeting, wishes to speak using their rights as a participant on the matter being discussed, they must temporarily hand over their position to another praesidium member.
3. If Praesidium 1, who is leading the meeting, requests to be replaced or is requested to be replaced by the assembly, they must hand over their position to another Praesidium member.

**CHAPTER V
QUORUM**

Article 15

1. The General Assembly GSD FVM UB is considered valid if attended by $\frac{2}{3}$ of the invited representatives of FVM UB students.
2. If the requirement in paragraph 1 is not met, the General Assembly GSD FVM UB will be postponed for 2 x 5 minutes.
3. If a quorum is still not reached after the allotted time, the General Assembly GSD FVM UB may proceed with the approval of the assembly.
4. If approved by the assembly, the General Assembly GSD FVM UB may continue and be declared valid.

**CHAPTER VI
INTERUPTIONSI**

Article 16

1. Every participant has the right to make an interruption to the Praesidium of the General Assembly GSD FVM UB..
2. The right to interruption is regulated by the General Assembly GSD FVM UB.
3. Interruptions are made by saying "interruption" or writing "interruption" in the chat column, followed by the type of interruption.
4. The types of interruptions are:
 - a) *Interruption of point of order* : to provide a personal opinion or viewpoint.
 - b) *Interruption of justification* : to support a previous opinion.
 - c) *Interruption of information* : to provide information..
 - d) *Interruption of clarification* : to provide clarification.
 - e) *Interruption of privilege* : to make a statement based on the AD-ART or GOWG (this is the highest form of interruption and cannot be interrupted further).

**CHAPTER VII
DECISION MAKING**

Article 17

1. Decision making is carried out by consensus.
2. If the requirement in paragraph 1 is not met, lobbying will be conducted, with its mechanism carried out within 1x10 minutes.
3. If the requirement in paragraph 2 is not met, decisions will be made based on the majority vote.
4. In the voting process, each full participant has one vote.
5. If there is an equal number of votes as stated in paragraph 3, the decision making is handed over to the assembly.
6. All decisions that have been made are final unless the assembly requests a review.
7. The Praesidium must strike the gavel for each decision made.

Article 18

Rules for Striking the Gavel:

1. The gavel is struck once for each decision made on a discussion point.
2. The gavel is struck twice for:
 - a. Each ratification of the meeting results
 - b. The conclusion of each session
 - c. Each change of meeting leadership
3. The gavel is struck three times to open and close the meeting.

CHAPTER VIII

RATIFICATION OF THE RESULTS OF THE GENERAL ASSEMBLY GSD FVM

UB

Article 19

1. Each unit of discussion decided in the General Assembly GSD FVM UB is considered a result of the General Assembly GSD FVM UB.
2. Each result of the General Assembly GSD FVM UB must be immediately ratified through a Decree of the General Assembly GSD FVM UB.

Article 20

1. Sanctions are given to participants who violate the Rules of Procedure of the General Assembly GSD FVM UB after being given three verbal warnings by the Praesidium of the General Assembly GSD FVM UB.
2. The sanction given as stated in paragraph 1 is the expulsion of the offending participant from the series of activities of the General Assembly GSD FVM UB.

**CHAPTER X
ADDITIONAL RULES**

Article 21

5. With the approval of the participants of the General Assembly GSD FVM UB.

CHAPTER XI

CLOSING

Article 22

The General Assembly GSD FVM UB begins on the date these Rules of Procedure are ratified and continues until the General Assembly GSD FVM UB is officially closed..

**CHAPTER I
MEMBERSHIP**

Article 1

Article 2

Obligations of Members of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya:

1. Every member of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya must uphold and maintain the good name of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya.
2. Every member of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya must uphold and comply with all regulations of the Statutes and Bylaws of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya, as well as all regulations that apply within the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya.

Article 3

Rights of Members of the Student Collegium of the Faculty of Veterinary Medicine Universitas Brawijaya:

4. To confirm the President and Vice President of the SEB, members of SRC, and the Chairpersons of the SAB of the Faculty of Veterinary Medicine Universitas Brawijaya.
5. To discuss and establish additional agendas
6. To decide and determine matters deemed necessary

1. General Session

Article 9

1. General and Extraordinary Sessions are conducted to carry out the duties and

4. The General and Extraordinary Sessions are considered valid with the quorum requirements as stipulated in the Rules of Procedure for the General and Extraordinary Sessions of the GSD Faculty of Veterinary Medicine Universitas Brawijaya

Article 10

1. A Special Session is held to demand accountability and to discharge the President of SEB, Vice President of SEB, Members of SRC, and Chair of SAB of the Faculty of Veterinary Medicine Universitas Brawijaya if they are proven to have violated the Statutes and Bylaws of the Kolegium Mahasiswa Fakultas Kedokteran Hewan Universitas Brawijaya and/or the GWG of the Kolegium Mahasiswa Fakultas Kedokteran Hewan Universitas Brawijaya

Article 12

1. Extraordinary Sessions are held to amend the Statutes and Bylaws of the Student Collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya, outside of the General Sessions of the General Student Deliberation of the Faculty of Veterinary Medicine, Universitas Brawijaya.
2. Extraordinary Sessions are convened upon the proposal of the Student Representative Council of the Faculty of Veterinary Medicine, Universitas Brawijaya.
3. Extraordinary Sessions are considered valid with a quorum requirement as stipulated in the Extraordinary Session Rules of Order of the General Student Deliberation of the Faculty of Veterinary Medicine, Universitas Brawijaya.

Article 15

The duties and authorities of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, are:

1. Supervising the SEB of the Faculty of Veterinary Medicine, Universitas Brawijaya, in implementing the GWG FVM UB, GSD FVM UB Decrees, and other regulations of the Student Collegium FVM UB.
2. Implementing the GWG of the Student Collegium FVM UB, GSD FVM UB Decrees, and other regulations of the Student Collegium FVM UB.
3. Absorbing and formulating the aspirations of members of the Student Collegium FVM UB and conveying them to the relevant parties.
4. If, in the view of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, the SEB of the Faculty of Veterinary Medicine, Universitas Brawijaya, does not perform its duties or deviates from the policy direction of GSD FVM UB, the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, has the authority to issue Memorandum I with a deadline of 30 days. If the SEB of the Faculty of Veterinary Medicine, Universitas Brawijaya,

If, after this period, the SEB of the Faculty of Veterinary Medicine, Universitas Brawijaya, does not make improvements, the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, has the authority to convene a Special GSD FVM UB Session.

5. Authorised to draft and enact laws that are subordinate to the Statutes and Bylaws of the Student Collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya.
6. Exercising the right to petition and the advocacy function possessed by the Student Representative Council of the Faculty of Veterinary Medicine, Universitas Brawijaya.
7. Conducting periodic performance evaluations of the Student Executive Board of the Faculty of Veterinary Medicine, Universitas Brawijaya, at least once every three months.
8. Reporting performance in written form to students at least three times periodically within one management period, with the first report being conducted three months after the GSD FVM UB.
9. Having the authority to coordinate and determine the distribution of finances in the budget plan of the student collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya.
10. Having the authority to supervise the use of funds for activities by the student collegium organisations of the Faculty of Veterinary Medicine, Universitas Brawijaya.

3. Members of the SRC hold office for one period and can be re-elected afterward

Article 18

Rights and Responsibilities of Members of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya:

1. Every member of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, has the right to initiative, inquiry, questioning, interpellation, and petition.
2. Every member of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, is obligated to act as a responsible representative of the students.

3. Daily Management of Intra-Campus Activity Units at Universitas Brawijaya.

Article 21

Members of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, are not allowed to participate in other committees at the faculty or university level, except as part of the Steering Committee..

Article 22

Members of the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, are accountable to the GSD of the Faculty of Veterinary Medicine, Universitas Brawijaya.

Article 23

Membership in the Student Representative Council (SRC) of the Faculty of Veterinary Medicine, Universitas Brawijaya, can be terminated if:

1. The member passes away.
2. The member is proven to have committed fraud during the election process.

Article 26

A Plenary Meeting is a meeting held by the SRC of the Faculty of Veterinary Medicine, Universitas Brawijaya, to make decisions binding on all members of the SRC.

Article 27

A Leadership Meeting is attended by the Chair of the SRC and the Chairs of the Commissions to schedule and formulate the meeting agendas.

Article 28

Commission Meeting:

1. A Commission Meeting is a meeting held by each Commission.
2. A Commission Meeting is a meeting that determines or formulates the aspirations of students of the Faculty of Veterinary Medicine, Universitas Brawijaya, which are channeled through the SRC Faculty of Veterinary Medicine, Universitas Brawijaya.
3. A Commission Meeting is led by a Commission Chair who is elected from among the Commission Members.

Article 31

Duties and Authorities of the SEB of the Faculty of Veterinary Medicine Universitas Brawijaya:

9. The BEM of the Faculty of Veterinary Medicine, Universitas Brawijaya, has the authority to monitor and evaluate the SAB of FVM UB..

Article 32

The Student Executive Body (BEM) of the Faculty of Veterinary Medicine, Universitas Brawijaya, is led by a President and assisted by a Vice President of BEM, who are elected through the Student Election, appointed by the General Assembly of GSD FVM UB, and subsequently inaugurated by the Leadership of the Faculty of Veterinary Medicine, Universitas Brawijaya.

Article 33

Management Structure of BEM at the Faculty of Veterinary Medicine, Universitas Brawijaya:

1. The management of BEM at the Faculty of Veterinary Medicine, Universitas Brawijaya consists of the President, Vice President, and their cabinet.
2. The number and composition of the cabinet and staff are adjusted according to needs.
3. The term of office for the President, Vice President, and their cabinet is one management period of BEM at the Faculty of Veterinary Medicine, Universitas Brawijaya.
4. In forming the management, the President of BEM at the Faculty of Veterinary Medicine, Universitas Brawijaya has prerogative rights.

5. Clubs are under the auspices of the ministries of BEM at the Faculty of Veterinary Medicine, Universitas Brawijaya and operate in the field of interests and talents.

Article 34

Article 35

The President of the Student Executive Board (BEM), the Vice President of the Student Executive Board, and Ministers and Officials equivalent to Ministers are not permitted to participate in other student committees at the faculty or university level, except as members of the Steering Committee.

Article 36

1. The President of the Student Executive Board (BEM) of the Faculty of Veterinary Medicine at Universitas Brawijaya is accountable to the General Assembly of Students (MUM) of the Faculty of Veterinary Medicine at Universitas Brawijaya.

SEMI-AUTONOMOUS ORGANISATIONS (SAO)

Article 39

2. The implementation of a referendum must be with the knowledge of the leadership of the Faculty of Veterinary Medicine, Universitas Brawijaya.
3. A referendum is considered valid if it is participated in by at least $\frac{2}{3}$ of the total members of the Student Collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya.
4. The result of a referendum for the dissolution of the Student Collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya, is considered valid if it is approved by at least $\frac{2}{3}$ of the total members of the Student Collegium of the Faculty of Veterinary Medicine, Universitas Brawijaya.
5. The result of a referendum on issues other than those listed in paragraph (3) is considered valid if it is approved by more than $\frac{2}{3}$ of the total participants in the referendum.
